

RESOLUTION NUMBER R- 265118

ADOPTED ON FEB 24 1986

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE PUBLIC STREETS, HIGHWAYS, AND SERVICE EASEMENTS VACATION LAW, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE THORN STREET BETWEEN KETTNER BOULEVARD AND CALIFORNIA STREET AND ADJACENT TO LOTS 1 AND 12, BLOCK 132, AND LOTS 6 AND 7, BLOCK 143, BOTH WITHIN MIDDLETOWN AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience of said City require the vacation of Thorn Street, hereinafter mentioned.

2. That it is the intention of said Council to order the vacation of Thorn Street between Kettner Boulevard and California Street, as more particularly shown on Drawing No. 16647-B on file in the office of the City Clerk as Document No.



3. That this Council hereby elects to proceed, in making said vacation under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law." California Streets and Highways Code section 8300 et seq.

4. That this Council hereby fixes 10:00 a.m. on April 1, 1986 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, San Diego, California as the time and place for hearing all persons interested in or objecting to the proposed vacation.

5. That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
