RESOLUTION NUMBER R- 265119

ADOPTED ON FEB 24 1986

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of streets and public service easements by City Council resolution where for a period of five consecutive years, the street or highway has been impassable for vehicular travel and no money was expended for maintenance on the street or highway during such period; and

WHEREAS, the abutting property owners have requested the vacation of the unnamed public street described per deed, recorded September 19, 1893 in Book 222, Page 339 of Book of Deeds, to facilitate development of their properties; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the unnamed public street described per deed, recorded September 19, 1893 in Book 222, Page 339 of Book of Deeds in connection with North City West Neighborhood 3, units 10 through 13, TM 85-0260, as more particularly shown on Drawing No.

16571-B on file in the office of the City Clerk as Document No.
RR- 265119, which is by this reference incorporated herein
and made a part hereof, be and the same is hereby ordered
vacated.

2. That the City Clerk shall cause a certified copy of this
resolution, with drawing, attested by him under seal, to be
recorded in the office of the County Recorder.

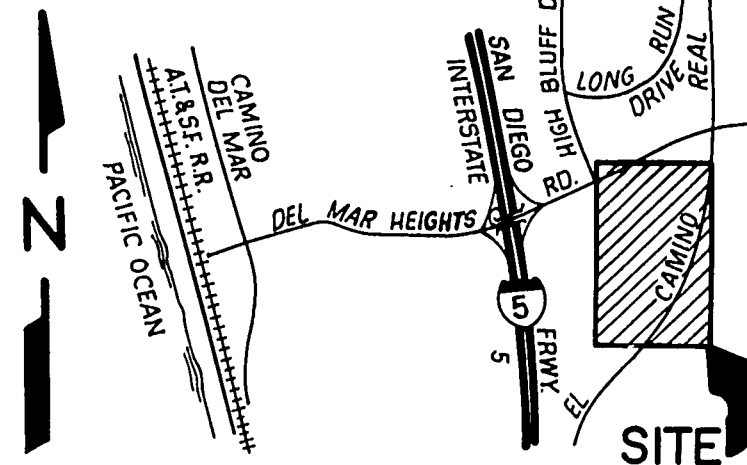
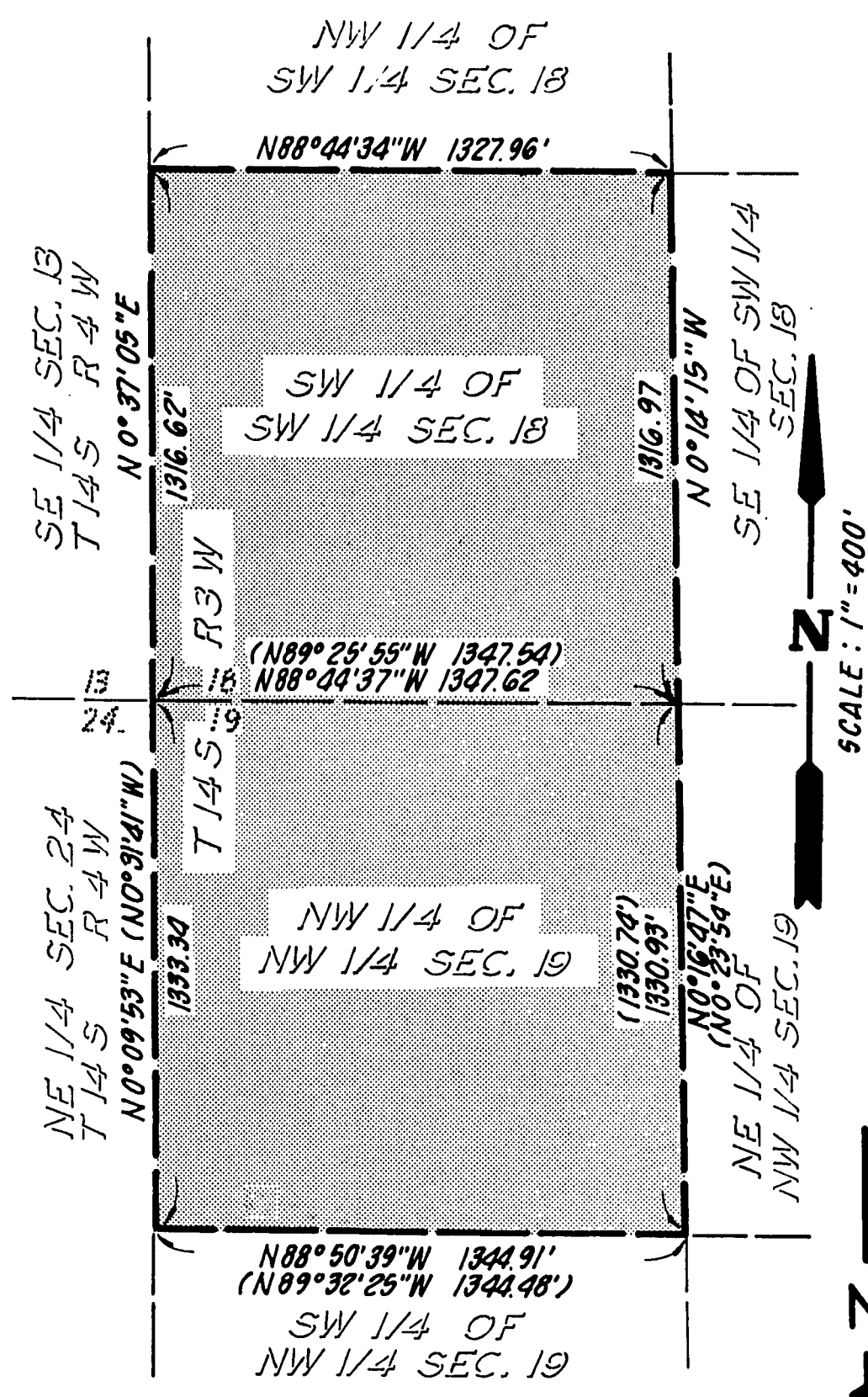
