WHEREAS, the Old San Diego Community Planning Committee has requested a name change to "Old Town Community Planning Committee" because they feel that the present title does not reflect the community which they represent; and

WHEREAS, the Committee believes that "Old Town" rather than "Old San Diego" more clearly captures the essence of the community; and

WHEREAS, the matter is set forth and analyzed in Planning Department Report No. 86-077, dated January 27, 1986; and

WHEREAS, the Planning Department recommended to the Rules Committee in said report that the Committee name be changed so that the historic significance of "Old Town" be recognized and accorded appropriate denomination; and

WHEREAS, the Rules Committee, on February 3, 1986, reviewed said recommendation and approved it by a 3-0 vote, with direction to forward the matter to the full Council for appropriate action thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the request by the Chairman of the Old San Diego Community Planning Committee to change the name of the committee to the OLD TOWN COMMUNITY PLANNING COMMITTEE, as recommended in Planning

Department Report No. 86-077, dated January 27, 1986, and approved by the Rules Committee on February 3, 1986, be and the same is hereby approved.
