

RESOLUTION NUMBER R- 265133 ADOPTED ON FEB 24 1986

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Fiscal Year 1986 Capital Improvements Program be amended by adding C.I.P. 12-057, Penasquitos Lagoon Management Program.
- 2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the Agreement with United States Geologic Survey, for cooperative investigation of the water resources of the City of San Diego, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- **265133** .
- That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$6,375.00 from C.I.P. 91-801.3, Revenue Sharing Reserve, Fund 18013, to C.I.P. 12-057, Penasquitos Lagoon Management Program.



4. That the expenditure of amounts not to exceed \$6,375 from C.I.P. 12-057 Penasquitos Lagoon Management Program, Revenue Sharing fund 18013 and \$6,375 from Deposit Trust Fund 63021, are hereby authorized, solely and exclusively for payment of City's share of the cost of installation of two stream flow/sediment gauges by the United States Geologic Survey.
