RESOLUTION NUMBER R- 265134
ADOPTED ON FEB 24 1986

WHEREAS, on February 3, 1986, the Rules Committee considered the matter of authorizing City staff to work with the City of Santee staff in identifying possible boundary line adjustments of mutual benefit; and

WHEREAS, this matter was initiated by a letter from the Mayor of Santee, Jack Doyle, dated December 17, 1985, to Deputy Mayor Ed Struiksma, in which he advised that Santee was interested in "pursuing the possible annexation of property" that is currently within the geographical jurisdiction of San Diego, in the belief that such annexation "could prove beneficial to both agencies"; and

WHEREAS, the Planning Department was directed to study this matter and report to Council in regard thereto; and


WHEREAS, the Planning Department submitted its Report No. 86-071, dated January 27, 1986, setting forth the issues and objectives and, in cooperation with the City Manager, recommended that City staff be authorized to work with Santee city staff in this matter; and

WHEREAS, the Rules Committee approved said recommendation by a 3-0 vote on February 3, 1986 and now forwards the matter to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the Planning Director and City Manager contained in Planning Department Report No. 86-071, dated January 27, 1986, regarding possible boundary line adjustments with the City of Santee be and the same are hereby approved.

BE IT FURTHER RESOLVED, that appropriate City of San Diego staff are hereby authorized to work with staff of the City of Santee for the purpose of identifying possible boundary line adjustments of mutual benefit to both agencies.
