WHEREAS, expenses for the operation and promotion of said District are funded by a special assessment levied by the City, with the concurrence of those assessed; and

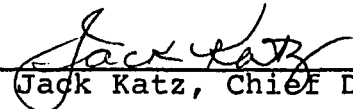

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute an agreement with the EL CAJON BOULEVARD "GATEWAY" BUSINESS IMPROVEMENT ASSOCIATION, INC., a nonprofit California corporation, for the purpose of providing professional and operational services in connection with the El Cajon Boulevard Business Improvement District, pursuant to the terms and conditions of the agreement on file in the office of the City Clerk as Document No. RR- 265136 .

BE IT FURTHER RESOLVED, that the budget submitted by said Association and incorporated in the above cited agreement be and the same is hereby approved.
