

RESOLUTION No. R- 265161 (R- 86-1426)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of INTEROX AMERICA is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing AN ESTIMATED 800,000 LBS. OF HYDROGEN PEROXIDE as may be required for a period of one (1) year beginning April 1, 1986 through March 31, 1987, at a cost of \$0.3290 per lb. for a total estimated cost of \$263,200.00; terms net 30 days, plus sales tax, with an option to renew contract for an additional one (1) year period at bid price.
