


RESOLUTION No. R-265162 (R-86-1424)

Adopted on MAR 3 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENT GROUP 67, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on MAR 3 1986 and bearing official Document No. W.O. 147172/148199 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SEWER AND WATER MAIN REPLACEMENT GROUP 67.
4. That the expenditure, not to exceed \$1,522,600 (\$1,183,000 from Sewer Revenue Fund 41506, CIP No. 44-001 ANNUAL ALLOCATION - MAIN REPLACEMENTS and \$339,600 from Water Revenue Fund 41502, CIP No. 73-083 ANNUAL ALLOCATION - MAIN REPLACEMENTS) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
