A RESOLUTION DECLARING THE RESULTS OF THE
SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF
SAN DIEGO, ON TUESDAY, FEBRUARY 25, 1986.

WHEREAS, a special municipal election was held in the City of San Diego, on Tuesday, February 25, 1986, pursuant to the provisions of Ordinance No. O-16568 (New Series) adopted December 17, 1985, for the purpose of electing a Mayor to fill the vacancy created by the resignation of Roger Hedgecock; and

WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the special municipal election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of the election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 179,105.

II
