BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bids of 1. H. G. FENTON MATERIAL CO. and 2. DAVE MARTIN SUPPLIES are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SAND, FILL SAND, MISCELLANEOUS BASE, AND DECOMPOSED GRANITE as may be required for a period of thirteen (13) months beginning March 1, 1986 through March 31, 1987, per prices on file in the Purchasing Department, as follows:
 - (1) H. G. FENTON MATERIAL CO. for Section I - Concrete Sand, Section II - Plaster Sand, and Section IV - Processed Miscellaneous Base; terms net, plus sales tax, with an option to renew contract for an additional one (1) year period.
 - (2) DAVE MARTIN SUPPLIES for Section V - Fill Sand and Section VI - Decomposed Granite; terms net, plus sales tax, with an option to renew contract for an additional one (1) year period.
2. That all bids for Section III - Concrete Aggregate and Section VII - Crushed Rock are hereby rejected.
