WHEREAS, in June 1986, the San Diego AIDS Project will sponsor a large star-studded benefit to raise funds to be distributed to the San Diego AIDS Project, the San Diego County AIDS Assistance Fund, the University of California at San Diego Medical Center for AIDS Research, and the American Foundation for AIDS research; and

WHEREAS, the show is entitled "Evening With Friends" and will be performed at the Civic Theatre; and

WHEREAS, it is very important to have the overall strong commitment of a cross-section of the community; and

WHEREAS, it has been requested by the past chairman of the San Diego County Board of Supervisors that a partial Civic Theatre rental fee of \$2,275 be waived by the City so that as much of the money raised by the event as is possible be directed to the underlying cause, with the remainder of the costs to be assumed by the sponsor of the show; and

WHEREAS, Council Policy 700-43 permits the waiver of fees in such cases as long as the City Council makes an equal reimbursement to the Performing Arts Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Council Policy 700-43, a partial waiver of fees for the Civic Theatre in the amount of \$2,275 is hereby granted, for the sole and exclusive purpose of providing use of the Civic Theatre in June 1986, for a show entitled "Evening With Friends."

BE IT FURTHER RESOLVED, that the City Council accepts the offer of and agrees that the sponsoring organization, the San Diego AIDS Project, will assume all of the remaining costs of the event.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$2,275 from the General Fund 100, Unallocated Reserve (605) to the Convention and Performing Arts Center Fund (10320) for the sole and exclusive purpose of reimbursing the Center in the amount of the above waived fees, pursuant to Council Policy 700-43, section A.4.
