

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$11,900 from CIP No. 29-470.0, King Elementary School/Stockton Recreation Center Athletic Field Park Service District Funds, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
