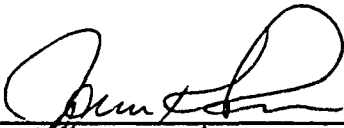

BE IT FURTHER RESOLVED, that Capital Improvement Program for FY'86 is hereby amended by adding Capital Improvement Program No. 52-399.0 SR 78 Widening Project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$55,050 from Gas Tax Fund 30219 CIP No. 52-300.0 Camino Del Rio and \$100,000 from Revenue Sharing Fund 18014 CIP No. 52-320.0 Woodman Street to CIP No. 52-399.0 SR 78 Widening Project.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$55,050 from Gas Tax Fund 30219 CIP No. 52.399.0 SR 78 Widening Project and \$100,000 from Revenue Sharing Fund 18014 CIP No. 52-399.0 SR 78 Widening Project, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
