Robert C. Hermann	Utilities	\$320.00	Mr. Hermann is an Electrician in the Buildings Division. He suggested the installation of reflectorized markers on curb faces to identify street light service points. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Rosario VanMantgem	Auditors	\$230.62	Ms. VanMantgem is the Senior Account Clerk. She suggested discontinuing writing warrant numbers on DP copies for SPSP records. This has resulted in a savings of \$768.72 in time. This is the full award.
Roy A. Knowles	Fire	\$100.00	Mr. Knowles is a Captain. He suggested the installation of hydrants with 4" ports in the Morena Business District. Although savings are difficult to identify, this is considered to be a significant operational improvement.
