Samuel L. Oates	Fire	\$ 90.00	Mr. Oates is a Fire Engineer. He suggested using a color-dot system on fire department maps to identify major target hazards. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Katherine Leach	Park & Recreation	\$ 26.91	Ms. Leach is an Intermediate Stenographer in the Eastern Division. She suggested eliminating the Pink & Goldenrod copies of the vehicle damage report (Form RM-151, September 1983). This has resulted in a savings of \$89.70 in materials. This is the full award.
