RESOLUTION NUMBER R- 265307

ADOPTED ON MAR 31 1986

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets by City Council resolution where a portion of street to be vacated is excess right-of-way and is not required for street or highway purposes; and

WHEREAS, the abutting property owners have requested the vacation of a portion of Roselle Street east of Tansy Street and adjacent to Lot C Acre Lot 33 of Sorrento Lands and Townsite; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and


WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

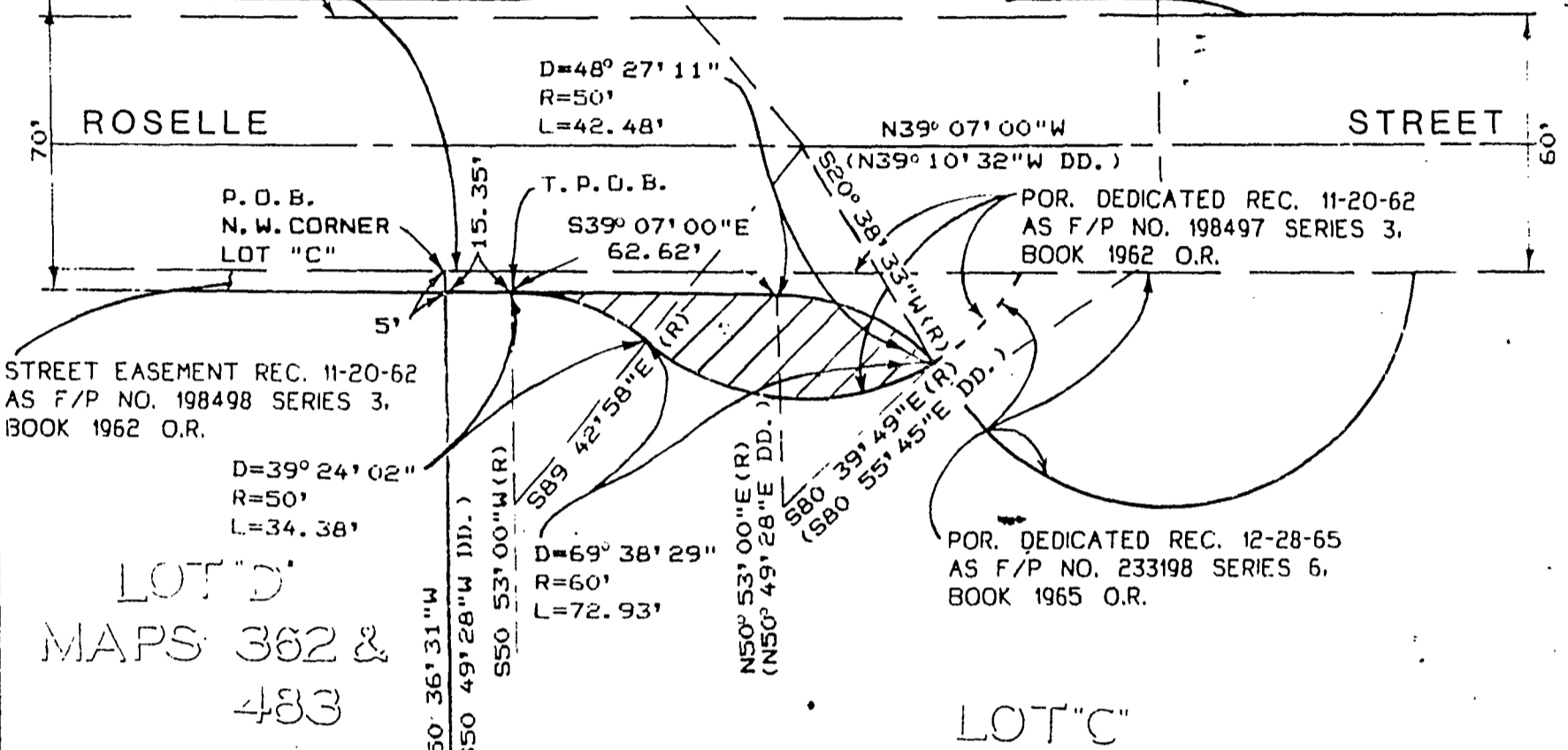
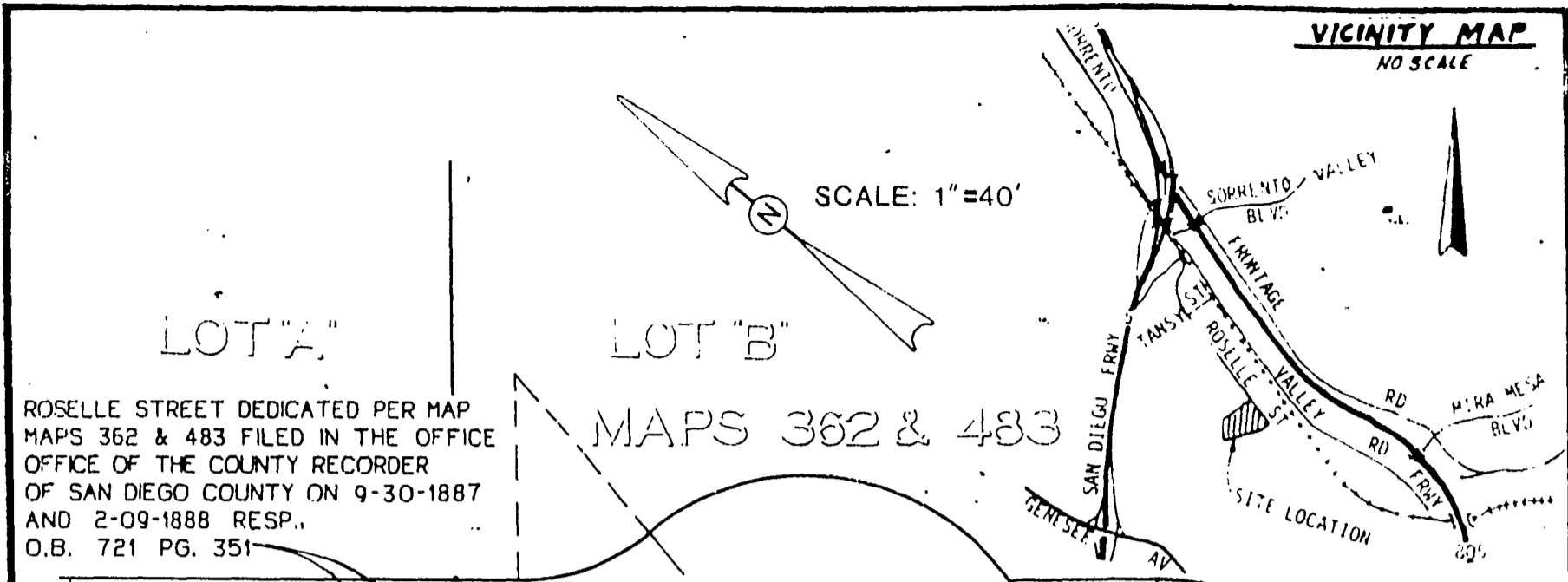

2. That the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
