

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$49,000 from PSD Fund 11700 CIP No. 23-386.1, Penn Athletic Area - Development, Phase III, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
