
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to enter into a contractual agreement with STRADLING, YOCCA, CARLSON & RAUTH for the provision of bond counsel services in connection with the financing of the Bayside Light Rail Transit Line, under the terms and conditions set forth in that document on file in the office of the City Clerk as Document No. RR- 265343.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$20,000 for said services, to be paid from the Public Transportation Reserve Fund, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that in the event and contingent upon the ultimate sale of bonds, additional fees based upon the amount of the bond issue for bond counsel services as set forth in said agreement, are hereby authorized and approved, solely and exclusively from the proceeds of such bond sale.
