WHEREAS, the Planning Commission of The City of San Diego held concurrent public hearings on October 3, 1985, to consider the proposed amendment of the SOUTHEAST SAN DIEGO COMMUNITY PLAN and amendment of the General Plan Map in order to retain consistency between said plans; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the amendment of the SOUTHEAST SAN DIEGO COMMUNITY PLAN and amendment of the General Plan Map; and

WHEREAS, City Council Policy 600-7, requires that the public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, on October 3, 1985, the Planning Commission approved and recommended for adoption by the City Council an amended GENERAL PLAN; and

WHEREAS, California Government Code, Section 65361 provides that mandatory elements of the GENERAL PLAN may not be amended more than four times per year; and

WHEREAS, it is the intention of the City Council to consider amendments of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semiannual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such

changes shall not become effective until enacted at the semiannual hearing conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the City Council held a public hearing to consider the amendment of the SOUTHEAST SAN DIEGO COMMUNITY PLAN; and

WHEREAS, the City Council, by majority vote, approved the amendment of the SOUTHEAST SAN DIEGO COMMUNITY PLAN; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That this City Council hereby approves the amendment of that plan entitled SOUTHEAST SAN DIEGO COMMUNITY PLAN, by incorporation therein of the SOUTHEAST SAN DIEGO COMMUNITY PLAN SOUTHCREST REDEVELOPMENT PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR-265347.
- 2. That the amendment of the SOUTHEAST SAN DIEGO COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plans at the next scheduled omnibus hearing.
