BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for NORTH TORREY PINES ROAD REVETMENT, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on APR 7 1986 and bearing official Document No. W.D. 118649 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for NORTH TORREY PINES ROAD REVETMENT.
4. That the City Auditor and Comptroller is hereby authorized to add CIP No. 37-192 NORTH TORREY PINES ROAD REVETMENT to the FY 1986 Capital Improvements Program.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$104,826 from CIP No. 91-801.3 REVENUE SHARING RESERVE FUND 18013 to CIP No. 37-192 NORTH TORREY PINES ROAD REVETMENT.
6. That the expenditure, not to exceed \$104,826 from CIP No. 37-192 NORTH TORREY PINES ROAD REVETMENT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
