
RESOLUTION NUMBER R- 265369

BE IT FURTHER RESOLVED, that Performance Bond No. 136134, issued by INSURANCE COMPANY OF THE WEST, in the amount of \$36,914.24 is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that Letter of Credit No. S-D3585SBY, issued by SECURITY PACIFIC NATIONAL BANK, in the amount of \$36,914.00, is hereby released.
