- 2. That the acceptance by the City Manager of a slope and street easement deed of CARMEL MOUNTAIN RANCH, a California partnership, executed in favor of The City of San Diego, bearing date of June 11, 1985, a copy of which deed is on file in the

office of the City Clerk as Document No. RR-265378; granting to the City easements for slope and public street purposes in portions of Parcel "A" and Lots 5 and 6 of Map No. 10382, and in a portion of Parcels 1 and 3 of Parcel Map No. 13864, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street and the same is hereby named CAMINO DEL NORTE.


