RESOLUTION NUMBER R- 265380

ADOPTED ON APR 7 1986

WHEREAS, there is no comprehensive, coordinated state program addressing the problems of the homeless; and

WHEREAS, AB 2839 creates an office of Homeless Services in the governor's office and directs that office to allocate \$30 million annually to county homeless centers; and

WHEREAS, the need in San Diego for the services funded by this bill is well documented; and

WHEREAS, the Rules Committee, on March 17, 1986, considered Intergovernmental Relations Department Report No. 86-6 on the bill; and

WHEREAS, the Rules Committee was assured that the author of the bill would consider amendments; and

WHEREAS, the Rules Committee voted 4-0 to support the bill and instruct the City's legislative representative to seek certain amendments; and

WHEREAS, the Rules Committee now forwards the matter to the full Council for action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby declare its support for AB 2839.

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department is directed to seek amendments that:

1. Require representation of cities of sizeable population on the county advisory committee.
2. Explicitly provide that counties are released from any mandated activities in the event state funding is not available.
3. Limit eligibility for services in the same manner prescribed for eligibility for such entitlement programs as AFDC, Medi-Cal and S.S.I.
