RESOLUTION NUMBER R- 265381

ADOPTED ON APR 7 1986

WHEREAS, the San Diego Port District Act was enacted by the Legislature and ratified by the voters in 1962; and

WHEREAS, this Act specified that the City of San Diego be allocated three representatives to the board of commissioners; and


WHEREAS, the City of San Diego has the largest population of the cities in the Port District and the largest percent of total tidelands which have been granted to the Port District; and

WHEREAS, SB 1742 (Ellis) proposes the reduction of the board of commissioners to five and the City of San Diego's appointed commissioners to one, as well as requiring the commissioners to be members of the appointing city council; and

WHEREAS, the Rules Committee reviewed Intergovernmental Relations Department Report No. 86-14 which recommended opposition to SB 1742 (Ellis) and approved that recommendation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Intergovernmental Relations Department and its Sacramento representative be, and they are hereby directed to oppose SB 1742 (Ellis).
