RESOLUTION NUMBER R- 265382

ADOPTED ON APR 7 1986

WHEREAS, on March 10, 1986, the City Council adopted the recommendation of the City Manager to elect to either bind or not bind public liability insurance depending upon the availability and affordability of any quotes obtained by the City's broker of record, Marsh and McLennan, Inc., upon the City's current policy expiration date of March 13, 1986; and

WHEREAS, the only quote received for public liability insurance coverage has been reviewed and rejected because of the absurdly high premium for the limited coverage; and

WHEREAS, as a result thereof, it is recommended that the City Manager be authorized to not purchase public liability insurance coverage and to self-insure its public liability exposure; and

WHEREAS, the City Manager provided the background and discussion of the matter in his Report No. 86-122, dated March 13, 1986, to the Rules Committee; and

WHEREAS, on March 17, 1986, the Rules Committee considered the matter and information contained in City Manager Report No. 86-122 and approved the City Manager's recommendation by a 4-0 vote; and

WHEREAS, the matter is now forwarded to the full Council for action thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations set forth in City Manager Report No. 86-112

to: (1) authorize the City Manager to not purchase public liability insurance on the expiration date of March 13, 1986 due to the unaffordability and unavailability of insurance coverage and to instead self-insure the City's public liability exposure; and (2) direct the broker of record, Marsh and McLennan, Inc. to continue their search of the excess liability insurance market for cost effective public liability insurance, be and the same are hereby approved.
