ADOPTED ON APR 7 1986

WHEREAS, the San Diego County Fish and Game Association is a county-wide 3,000 member organization of men and women devoted primarily to fishing, hunting and shooting sports; and

WHEREAS, for the last 27 years they have sponsored the annual event known as the "Maurice Weinberger Memorial Kid's Fishing Day"; and

WHEREAS, this event consists of Association members and volunteers introducing children 12 years of age and under to fishing and assisting them in their efforts; and


WHEREAS, the City's current fee schedule allows children seven and under to fish for free and children eight through 15 are charged \$2.50 during trout season and \$2.00 at all other times; and

WHEREAS, the value of fish planted by the Association exceeds the normal value of permit fees waived for youngsters between eight and 12 years of age; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the waiver of youth permit fees participation in Kids' Fishing Days sponsored by the San Diego County Fish and Game Association at Lake Otay on April 26, 1986 and Lake Miramar on May 3, 1986, is hereby authorized.
