

RESOLUTION NUMBER R- 265385 ADOPTED ON ____APR 7 1986

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That FY'86 Capital Improvement Program be amended by adding CIP No. 11-299, Otay Mesa Drainage Master Plan.
- 2. That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Leedshill-Herkenhoff, Inc., for engineering consultant services, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-265385.
- 3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$51,300 from CIP No. 91-801.3, Revenue Sharing Unallocated Reserve to CIP No. 11-299, Otay Mesa Drainage Master Plan.
- 4. That the expenditure of an amount not to exceed \$49,300 from CIP No. 11-299, Otay Mesa Drainage Master Plan, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.



5. That this Council waives the provisions of Council Policy No. 300-7 with respect to Consultant Services Selection.
