WHEREAS, this plan uses as its basis the research and planning efforts of the past five years supplemented with individual interviews and group meetings with representatives of the arts and civic communities; and


WHEREAS, the Public Arts Advisory Board of the City of San Diego has endorsed the twelve goal statements of this plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council accepts the "Arts Plan for the City of San Diego: 1986; Part I" as meeting the planning requirements of the State/Local Partnership Program of the California Arts Council; and

BE IT FURTHER RESOLVED, that the Intergovernmental Relations Department be requested to include this plan with the City's FY '87 grant application to be submitted to the California Arts Council no later than March 14, 1986.
