


RESOLUTION No. R-265390 (R-86-1620)

That the bid of T & J GARAGE, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of REFUSE TRUCKS - Item 1 fourteen (14) each twenty-five (25) cubic yard high density rear loader Refuse Packers (Crane Carrier LETC-3814 cab and chassis with a Dempster RKII-250 packer body) at a cost of \$106,036.00 each, for a total cost of \$1,484,504.00; terms net 20 days, plus sales tax.
