
APPROVING REVERSIONARY MAP OF NORTHEAST

BE IT RESOLVED, that the Council of The City of San Diego hereby finds that certain map surveyed by Reginald Dale Harvey, Jr., Licensed Land Surveyor, entitled "REVERSIONARY MAP OF NORTHEAST UNIVERSITY CITY UNIT NO. 1 being a reversion to acreage of Lots 1 through 129 inclusive of Northeast University City Unit No. 1 according to map thereof No. 9492 filed in the office of the County Recorder of San Diego County December 12, 1979, together with Rothschild Drive, Rembrandt Drive, Michaelangelo Drive and Nobel Drive as vacated and closed to public use, by filing of a reversionary map as provided in Section 66499.18 of the Subdivision Map Act, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys and said map is hereby approved and accepted.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said reversionary map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego.
