SUMMERS, INC., subdivider of UNIVERSITY CITY UNIT NO. 1, entered into an agreement with THE CITY OF SAN DIEGO to complete certain public improvements in said subdivision, a copy of which agreement is on file in the office of the City Clerk as Document No. RR-250658; and

WHEREAS, none of the improvements have been completed and the subdivider desires to terminate the agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the agreement of November 19, 1979, documented as No. RR-250658, in the office of the City Clerk be, and the same is hereby terminated.
