
ADOPTED ON APR 7 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of FEDERAL SAVINGS AND LOAN INSURANCE CORPORATION as Receiver for San Marino Savings and Loan Association, a California corporation, executed in favor of The City of San Diego, bearing date of October 28, 1985, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 265397, granting to said City an easement for public street purposes in Parcel 1 of Parcel Map No. 11842 and in Lot 2 of the Reversionary Map of Northeast University City Unit No. 1, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named NOBEL DRIVE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
