ADOPTED ON APR 7 1986

WHEREAS, the San Diego Daily Transcript is officially completing 100 years of publication in April 1986; and

WHEREAS, the Daily Transcript was actually established in 1882 but its establishment date was mysteriously changed to 1886 in 1909 and has been thought ever since to have been established in 1886; and

WHEREAS, Frank Grandier, a French nobleman, redesigned the newspaper at the turn of the century to serve the legal and business communities; and

WHEREAS, Lydia Landon Grandier professionally carried on the work of her husband after 1941; and

WHEREAS, in 1960, Aline Grandier Hornaday continued publishing the newspaper after her parents; and


WHEREAS, former banker Keith Lister acquired the newspaper in 1972 and further redesigned it to emphasize coverage of San Diego's growing commerce, industry, banking, real estate, construction, legal affairs and government; and

WHEREAS, the Daily Transcript has delivered to the public, important breaking news affecting the public's welfare; and

WHEREAS, the Daily Transcript has championed the renaissance of San Diego's downtown and has cultivated San Diego's finest journalists; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that
in observation and recognition of the 100th anniversary of the
Daily Transcript, April 1986 be proclaimed San Diego Daily
Transcript Month in The City of San Diego.
