BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. H. G. FENTON MATERIAL COMPANY, 2. ASPHALT, INC., 3. NELSON & SLOAN and 4. DAVE MARTIN SUPPLIES INC. are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of CONCRETE AGGREGATE AND CRUSHED ROCK as may be required for a period of eleven and one half (11½) months beginning April 16, 1986 through March 31, 1987, per prices on file in the Purchasing Department as follows:

1. H. G. FENTON MATERIAL COMPANY for Item 1 - No. 4 Concrete Aggregate, Item 4 - 3/8" Crushed Rock, Item 6 - 1" Crushed Rock; terms net, plus sales tax, with an option to renew contract for an additional one (1) year period.
2. ASPHALT, INC. for Item 2 - No. 3 Concrete Aggregate; terms \$.30 per ton 20 days, plus sales tax, with an option to renew contract for an additional one (1) year period with potential escalation during the option year not to exceed 5%.
3. NELSON & SLOAN for Item 3 - No. 2 Concrete Aggregate; terms net, plus sales tax, with potential escalation during contract period of 5%, with an option to renew contract for an additional one (1) year period with potential escalation during the option year not to exceed 10%.
4. DAVE MARTIN SUPPLIES INC. for Item 5 - 3/4" Crushed Rock; terms net, plus sales tax, with an option to renew contract for an additional one (1) year period.
