

FOR PT. LOMA WASTEWATER PLANT at a cost of \$46,279.00; terms 2% 10 days, plus sales tax, plus a \$500.00 delivery and set up charge, plus registration fees; with a buy-back at the end of three (3) years of \$8,222.00.
