WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be abandoned by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the general utility, sewer, water, storm drain and open space easements, as shown on Drawing No. 22429-D, are hereby abandoned in exchange for those easements granted on the final map of The Bluffs of Hillsborough.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver a certified copy of this resolution to the Engineering and Development Department for further handling.
