ADOPTED ON APR 14 1986

WHEREAS, the Canyon Rim Task Force was created as a result of the devastating fire in the Normal Heights area closest to the canyons south of Interstate 8; and

WHEREAS, said Task Force was charged with presenting recommendations to avoid future similar conflagrations; and

WHEREAS, the Task Force's report was directed to the City Manager for appropriate response; and

WHEREAS, the City Manager has responded by report to the Public Services and Safety (PS&S) Committee; and

WHEREAS, the PS&S Committee considered and discussed said City Manager's report at its regularly scheduled meeting of February 19, 1986, and by a 5-0 vote, accepted the City Manager's recommendations and further directed the City Manager, in cooperation with the Intergovernmental Relations Department, to take necessary actions regarding availability of surplus helicopters for firefighting purposes; and

WHEREAS, the matter is now forwarded to the full Council for appropriate action thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and the Director of Intergovernmental Relations be and they are hereby directed to jointly contact The City of

San Diego's federal legislative delegation regarding the availability of surplus helicopters for firefighting purposes.
