WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Vincent DeLeva	General Services	\$1,245.28	Mr. DeLeva is an Electrical Supervisor in the Communications & Electrical Division. One year ago, he earned a partial award of \$1,165 for his suggestion to replace damaged steel and concrete traffic signal and street light poles with fiberglass poles. One year's experience has shown a savings of \$8,034.28 in time and material. This is the remainder of his award.
Mary Tilotta	Library	\$ 765.46	Ms. Tilotta was a Junior Typist at the time of this suggestion. She suggested that the Library's Central Sections annotate order cards and eliminate a similar procedure in the Extension Division. One years experience has shown a savings of \$2,551.52 in time and material. This is the full award.
