Yolanda Garcia	Purchasing	\$25.00	Ms. Garcia is an Intermediate Typist. She suggested the use of a different binder for specification books to reduce the possibility of injury from a metal device. Although savings were difficult to identify, this was considered to be a significant safety improvement.
