
RESOLUTION NUMBER R- 265461

BE IT RESOLVED, by the Council of The City of San Diego that pursuant to California Public Resources Code, Section 21081, the City Council hereby adopts the findings made with respect to the feasibility of the mitigating measures and project alternatives contained in the ENVIRONMENTAL IMPACT REPORT for the amendment to the TIERRASANTA COMMUNITY PLAN (Lusk Tierrasanta Norte), and the rezoning of a portion of Parcels 1 through 7, Parcel Map No. 8547, a portion of Parcel 9, Parcel Map No. 13739, and a resubdivision of Villa Mesa Unit Nos. 1, 2 and 3, Map Nos. 10185, 10186 and 10187 (a 292-acre site), located generally east of Santo Road, south of the future rights-of-way of State Route 52, west of Mission Trails Regional Park and north of Clairemont Mesa Boulevard, in the Tierrasanta Community Plan area, on file in the office of the City Clerk as EIR-84-0749/84-0754/85-0272.
