That the expenditure, not to exceed \$284,000 from Capital Outlay Fund 30245, CIP No. 37-411 CITY OPERATIONS BUILDING COMMUNICATIONS AREA SECOND EXIT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
