


RESOLUTION No. R- 265478 (R-86-1880)

Adopted on APR 21 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MODIFICATION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS ON BARNETT AVENUE AT MIDWAY DRIVE AND AT M.C.R.D. GATE #2, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on APR 21 1986 and bearing official Document No. W.O. 118587 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MODIFICATION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS ON BARNETT AVENUE AT MIDWAY DRIVE AND AT M.C.R.D. GATE #2
4. That the City Auditor and Comptroller is hereby authorized to modify CIP No. 62-210 BARNETT AVENUE AND MIDWAY DRIVE to include modification of traffic signal at Barnett Avenue and M.C.R.D. Gate No. 2.
5. That the expenditure, not to exceed \$133,000 from CIP No. 62-210 BARNETT AVENUE AND MIDWAY DRIVE Revenue Sharing Fund 18013 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
