That the expenditure, not to exceed \$133,000 from CIP No. 62-210 BARNETT AVENUE AND MIDWAY DRIVE Revenue Sharing Fund 18013 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
