BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Douglas C. Paul, Registered Civil Engineer, entitled "N.C.W. NEIGHBORHOOD 3, UNIT 11 being a subdivision of a portion of the southwest quarter of Section 18, Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to official plat thereof together with a portion of Long Run Drive as dedicated to public use, together with an unnamed public street and portions of Del Mar Heights Road and El Camino Real as closed and vacated to public use excepting all oil rights on hereon described property to be reserved by the grantor, her heirs and assigns, forever, and further that the said grantor, her heirs or assigns agree to pay a reasonable compensation to the said grantee or their assigns, should the said grantor, her heirs or assigns, enter the herein described land for the purpose of drilling for oil," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Kinsella Point and Fallon Circle, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Del Mar Heights Road, adjacent and contiguous to Parcels "B" and "C," in and to El Camino Real, adjacent and contiguous to Parcels "C" and "D," all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water, sewer, drainage and general utility facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easements over, under upon and across portions all of Lot 5, all those portions of Lots 3, 4, 6 and 7, and all of Parcels "B," "C," and "D," as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of El Camino Real and Del Mar Heights Road, approved by Council Resolution No. R-265140, on February 24, 1986, concurrently with the filing of the map.
