
ADOPTED ON APR 21 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those drainage and street easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, dated April 2, 1985; THE CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER DAY SAINTS, a Utah corporation sole, dated February 10, 1986; LEO ANTHONY MCGUIRE, dated October 25, 1985; DOUGLAS ALLRED DEVELOPMENT COMPANY, INC., a California company, dated October 4, 1985; PARDEE CONSTRUCTION COMPANY, a California corporation, dated May 9, 1985; and VILLAGE PROPERTIES, a partnership, dated May 31, 1985, all executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-265488-1, RR-265488-2, RR-265488-3, RR-265488-4, RR-265488-5, RR-265488-6, RR-265488-7 and RR-265488-8, granting to said City easements for drainage purposes and public street purposes in Section 18, Township 14 South, Range 3 West, San Bernardino Meridian, and in Parcels 1 and 2 of Parcel Map 13449, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named DEL MAR HEIGHTS ROAD, HARTFIELD AVENUE, TORREY RIDGE DRIVE, TORREY BLUFF DRIVE AND CARMEL COUNTRY ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
