BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Charles R. Deck, Licensed Land Surveyor, entitled "WILSHIRE TERRACE CONDOMINIUMS being a subdivision of the westerly 65 feet of the easterly 130 feet of Lots 47, 48, 49 and the westerly 65 feet of the easterly 130 feet of the southerly 12-1/2 feet of Lot 50, Block 254 of University Heights in the City of San Diego, County of San Diego, State of California, according to the amended map thereof made by G. A. D'Hemecourt in Book 8, Page 36 et seq. of lis pendens in the office of the County Recorder of said San Diego County," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


