WHEREAS, the vacation of the City's interest in an unneeded pedestrian and non-motor vehicular easement affecting a portion of Pueblo Lot 1318, as more particularly shown on Drawing No. 21874-D on file in the office of the City Clerk as Document No. RR- 265519¹, has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has never been used, and is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the pedestrian and non-motor vehicular easement, as more particularly shown on Drawing No. 21874-D, is hereby vacated.

2. That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this

resolution, attested by him under seal, to be recorded in the office of the County Recorder.
