
WHEREAS, in a letter dated December 11, 1985, the Rancho de los Penasquitos Planning Board has requested that the Council of The City of San Diego take action to correct the mapping of the Penasquitos East Community Plan boundaries to coincide with the map dated December 11, 1985, on file in the office of the City Clerk as Document No. RR- 265524-1; and

WHEREAS, the Council of The City of San Diego has determined that, based upon information supplied with the Planning Board request, an error was made in drawing the map of the Penasquitos East Community Plan (Planned Urbanizing) boundaries, and that certain property identified as Carmel Rancho 2 on the map dated March 14, 1986, on file in the office of the City Clerk as Document No. RR- 265524-2, was, ab initio, located within the Penasquitos East Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the map showing the boundaries of the Penasquitos East Community Plan is hereby corrected as shown on the map dated December 11, 1985, on file in the office of the City Clerk as Document No. RR- 265524-1, to include property identified as Carmel Rancho 2 on the map dated March 14, 1986, on file in the office of the City Clerk as Document No. RR- 265524-2.
