## RESOLUTION NUMBER R- 265525 ADOPTED ON APR 21 1986

WHEREAS, the Council of The City of San Diego has approved a 4/10 Plan (4 ten-hour days) for field police officers; and

WHEREAS, The City of San Diego supports the concept of enhanced officer safety through acquisition of safety equipment for police officers; and

WHEREAS, the City has need for additional marked police vehicles and safety equipment; and

WHEREAS, the Council has previously authorized the purchase of new police vehicles and a trade-in allowance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That Resolution No. R-265054 adopted February 18, 1986, is hereby modified to reduce the trade in equipment from 60 each, 1983 Crown Victorias to 26 each, 1983 Crown Victorias.
- 2. That the additional expenditure of \$58,412 from Fund 100/110, Job Order 111475 to supplement funds previously authorized by Resolution No. R-265054 adopted February 18, 1986 for the purchase of police vehicles is hereby authorized solely and exclusively to provide additional funds to offset the reduction in the number of trade-in vehicles.
- 3. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for

services of a vendor or vendors to furnish switch control consoles for marked police vehicles in accordance with the specifications on file in the office of the City Clerk as Document No. RR- 265525

- 4. That the City Manager is hereby authorized to execute a contract with the lowest responsive and reliable bidder or bidders to furnish switch control consoles.
- 5. That the City Manager is hereby authorized to contract for purchase of sirens for police vehicles under California State Contract No. 1-84-58-10.
- 6. That the expenditure, not to exceed \$88,420 from Fund 100/110, Job Order 111475, is hereby authorized solely and exclusively for the purchase of switch control consoles, sirens, and related costs.
