WHEREAS, traffic circulation in the eastern La Jolla region has reached the point of gross inconvenience and severe delay for the citizens living and working in this area; and

WHEREAS, traffic circulation in the eastern La Jolla region is becoming a serious threat to the public health and safety of all citizens transiting the area; and

WHEREAS, SANDAG is currently reviewing the Mid-Coast Light Rail Alignment Study and its related circulation patterns; and

WHEREAS, solutions to the circulation problems at Ardath Road and Interstate 5 and the Golden Triangle Transit Loop must be incorporated into the studies that SANDAG is currently reviewing;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego requests SANDAG to include in its budget and review process for the next year, possible solutions for the transit and traffic problems at Ardath Road and Interstate 5 and the Golden Triangle Transit Loop.
